






**Bottom View**






















Figure 6. On-Resistance Variation with Temperature








Figure 7. On-Resistance Variation with Temperature




Figure 9. Diode Forward Voltage vs. Current 10 8 6  $V_{GS}(V)$ 4  $V_{DS} = 20V, I_{D} = 50A$ 2 0 0 30 90 120 150  $Q_g$  (nC) Figure 11. Gate Charge






Figure 8. Gate Threshold Variation vs. Junction Temperature

Figure 12. SOA, Safe Operation Area











Figure 14. Transient Thermal Resistance


